# Meeting Minutes for March 2015 (con't.)

Our president, Billy Patterson gave an overview of his trip to the Annual AACA meeting in Philadelphia, PA in February.

1. Interior car cleaning (sponsered by Mcguires). The person conducting the seminar used crayon and chewing gum to show how these type stains/mess can be taking care of on car mats. ## Dad or Grandad To The Rescue!


Are you a Dad or Grandad that gets a call from a daughter, son or a grandkid when their car will not start. Well, a few weeks ago, I got one of those calls. Their 2008 SUV had to be left in the High School parking lot. I took some tools, a voltmeter, jumper cables, and an extra battery that was good. I was confident that I could get the disabled SUV started.

I got to the SUV before my daughter did. While I was waiting for her and the keys, I looked in the SUV and saw a bunch of wires for electronic accessories all over the console. I thought my grandson had run down the battery with all his electronic stuff. When my daughter arrived with the keys, neither the dash warning lights or the buzzer would work. I checked the battery voltage and it was less than 10 volts. Well the battery was dead, so I'll just put in the good battery and get it started. My good battery was just a little bigger in physical size, and it fit in the tray. However, the positive cable barely fit and the negative cable would not fit on the battery post. I used one side of the jumper cable to hook the negative post to the cable end. It turned over very slow and did not start. At this point I decided to take the dead battery home and charge it up. At home, I hooked up the charger and it read 12.2 volts and was 75% charged. I wondered, what the heck is that all about? I put it on a 12 amp charge and it was done in 15 minutes.

Driving back to the SUV, I had time to sort out the facts of what was going on here. I decided that I had a poor connection at the cable ends. Corrosion was not visible, but I decided to clean the cable ends chemically and physically. In other words, the battery was a little low, but the cable ends had hidden corrosion that almost completely insulated the battery from the entire electrical system. Cleaning the cable ends fixed the problem.

In conclusion, I always learn something. Touching the battery posts tests the battery voltage only. If touching the cable ends gives the same voltage, the connection is good. Any lower voltage at the cable ends indicates the cable ends need cleaning. If you still had a no start, you would need to test the cables for a voltage drop to determine a bad cable or loose connection. Good luck if you get one of those calls!
